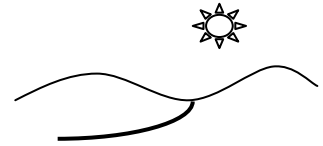

Acknowledgement of Event Participant Responsibility, Express Assumption of Risk, and Release of Liability

This document is an Agreement between the below named participant and Less Traveled Trails, LLC.

GENERAL PROVISIONS

I understand that during my participation in this Event by Less Traveled Trails, LLC that I may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in each Event and cannot be eliminated without destroying the unique character of the event. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, and death ("Injuries and Damages") from exposure to the hazards of travel and Less Traveled Trails, LLC has not tried to contradict or minimize my understanding of these risks. I know that Injuries and Damages can occur by natural causes or activities of other persons, animals, Event members, Event leaders and assistants and third parties, either as a result of negligence or because of other reasons. I understand that risks of such Injuries and Damages are involved in this Event provided by Less Traveled Trails, LLC and I appreciate that I may have to exercise extra care for my own person and for others around me in the face of such hazards. I further understand that on this Event there may not be rescue or medical facilities or expertise necessary to deal with the Injuries and Damages to which I may be exposed.

In consideration of my acceptance as a participant in this Event, and the services and amenities to be provided by Less Traveled Trails, LLC in connection with this Event, I confirm my understanding of the following additional Provisions:

1. I have read any rules and conditions applicable to the Event made available to me; I will pay any costs and fees for the Event; and I acknowledge my participation is at the discretion of the leader.
2. The Event officially begins and ends at the location(s) designated by Less Traveled Trails, LLC. The Event does not include carpooling, transportation, or transit before and after the Event, and I am personally responsible for all risks associated with this travel. This does not apply to transportation provided by Less Traveled Trails, LLC from the designated meeting location.
3. If I decide to leave early and not complete the Event as planned, I assume all risks inherent in my decision to leave and waive all liability against Less Traveled Trails, LLC arising from that decision. Likewise, if Less Traveled Trails, LLC has concluded the Event, and I decide to go forward without Less Traveled Trails, LLC, I assume all risks inherent in my decision to go forward and waive all liability against Less Traveled Trails, LLC arising from that decision.

4. This Agreement is intended to be as broad and inclusive as is permitted by law. If any Provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.
5. If I wish to know more information about this Event than directly provided by Less Traveled Trails, LLC, I will expressly request in a timely manner the specific information that I want to know in direct communication with Less Traveled Trails, LLC.
6. To the fullest extent allowed by law, I agree to waive, discharge claims, and release from liability Less Traveled Trails, LLC, its owner, manager, employees, agents, instructors, and field guides from any and all liability on account of, or in any way resulting from Injuries and Damages, even if caused by negligence of Less Traveled Trails, LLC, its owner, manager, employees, agents, instructors, and field guides, who are in any way connected with this Outing. I understand and intend that this Assumption of Risk and Release of Liability is binding upon my heirs, executors, administrators, and assigns, and includes any minors or animals of my responsibility accompanying me on this Event. I further agree to hold harmless Less Traveled Trails, LLC, its owner, manager, employees, agents, instructors, and field guides from any claims, damages, injuries, or losses caused by my own negligence while a participant in this Event. I understand and intend that this Assumption of Risk and release is binding upon my heirs, executors, administrators, and assigns, and includes any minors or animals of my responsibility accompanying me on this Event.
7. I have read this document in its entirety and I freely and voluntarily assume all risks of such Injuries and Damages and notwithstanding such risks, I agree to participate in the Event.
8. I have read, I understand, and I agree to the Less Traveled Trails, LLC Reservation and Cancellation Policy.
